Supervisor Hills will have Seat 1 with a four-year term; Supervisor Dister will have Seat 2 with a four-year term; Supervisor Motko will have Seat 3 with a two-year term; Supervisor Luce will have Seat 4 with a two-year term; and Supervisor Viera will have Seat 5 with a two-year term.
